A truck driver ran over a skim tank and caused 5 bbls of oil and 15 bbls of produced water to leak onto the ground. No fluids were recovered and precautionary measures have been taken to prevent future mishaps.

Describe Area Affected and Cleanup Action Taken.*
The affected area is approximately 45' x 45' with all of the leak staying inside the lined battery on location. Remediation will be completed according to a remediation plan approved by NMOCD.
