
Describe Cause of Problem and Remedial Action Taken.*

The affected area is approximately 60' x 60' on location. Remediation will be completed in accordance with a remediation plan approved by NMOCD.

This is to inform you that Oxy Permian had a leak at the Two Marks 36 State #4 SWD Battery on June 24, 2015. Oxy spilled 0.5 bbl of oil and 14.5 bbls of water due to a leak in a 2.875" steel oil dump line. The preliminary report shows the leak measuring approximately 30' x 30' on location. No fluids were recovered. The release is located in the SE ¼ of Section 36, T21S, R24E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From Carlsbad, go North on Hwy 285 to mile marker 44, go left on Water Hole Rd 1 mile to Big Walt Battery sign, go an additional 5 miles to next Big Walt Battery sign, pass the Big Walt Battery, turn right and continue to location.
