
Describe Cause of Problem and Remedial Action Taken.*

Surface steel water line developed a pinhole due to corrosion and produced water was released onto the well pad. The line was clamped, then isolated and repaired.

Describe Area Affected and Cleanup Action Taken.*

Leak affected 334 square feet of well pad within the bermed and fenced area. Vacuum truck recovered standing fluids. Impacted area was covered with plastic to prevent downward migration until addressed.


