The referenced oil well was completed on April 24, 2010 in the Empire, Glorieta-Yeso (96210). LRE has submitted the attached NOI sundry to recomplete into the upper pool, the Red Lake, Queen-Grayburg-San Andres (51300). Interests in these two pools are identical. Notice has also been given to the NM Commissioner of Public Lands.

LRE plans to produce the upper pool (San Andres) alone for a period of about 1 month in order to allow the production to stabilize. The production allocations will then be calculated using the stabilized production of the upper pool and the current (Yeso) production of 10 BOPD, 41 MCF/D, and 14 BWPD. We plan to submit these calculations and the resulting allocations to the district office for approval.



Set a 5-1/2" CBP @ ~3210' & PT to ~3500 psi. Perf San Andres @ ~2853'-3145' w/~29 holes. Stimulate with ~1500 gal 15% HCL acid & frac w/~30,000# 100 mesh & ~287,280# 40/70 Ottawa sand in slick water.




