There was a pin hole on a 2" line off of the wellhead, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 10' X 50'. The well was shut in, a vacuum truck was called to recover the released fluids, and repairs were made to the 2" line. Impacted soils excavated /hauled to a NMOCD approved facility. **Depth to Ground Water: < 50' (approximately 35', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20. Based on most of the released fluid recovered and repairs made to the poly line, Yates Petroleum Corporation requests closure.**
