Dear Mr. Hoover:

Our August 2, 1996 approval letter for the referenced downhole commingling application had the incorrect legal description and lease number.

The Pictured Cliffs formation had a 1996 mid-year production average of 78 Mcfpd, with a bottom hole pressure of 683 psi and a BTU value of 1134. The Mesaverde formation had a 1996 mid-year range of 180 Mcfpd and a yield of .0001 BO/Mcf, with a bottom hole pressure of 339 psi and a BTU value of 1081. Using these figures, the allocation for this well will be as follows:

Formation	Gas Allocation	Oil Allocation
Pictured Cliffs	30%	0%
Mesaverde	70%	100%

The Farmington District Office (FDO) of the Bureau of Land Management (BLM) has received your correspondence on July 26, 1996, for downhole commingling of the Blanco Mesaverde and Blanco Pictured Cliffs in the above referenced well.

The Pictured Cliffs formation had a 1996 mid-year production average of 78 Mcfpd, with a bottom hole pressure of 683 psi and a BTU value of 1134. The Mesaverde formation had a 1996 mid-year range of 180 Mcfpd and a yield of .0001 BO/Mcf, with a bottom hole pressure of 339 psi and a BTU value of 1081. Using these figures, the allocation for this well will be as follows:

Formation	Gas Allocation	Oil Allocation
Pictured Cliffs	30%	0%
Mesaverde	70%	100%
