#### Mr. Guye,

I aplogize for being slow to follow up to your prior e-mail re status of the NGX McKee St. 1 oil spill cleanup, where at the time I was basically living at a well site in Catron County, N.M. NGX has hired Michael Schultz to handle this cleanup to NMOCD specifications and of course subject to your review. Michael may have already proceeded with this project cleanup, including soil samples for geochemical analysis per coordination with your office, or otherwise he is the process of doing this work. In either event I'm currently more freed up from working 7-24 in CO2 field in western NM and eastern AZ, and I will stay focused on wrapping up this NGX cleanup to your satisfaction.

I believe you may have previously met Michael Schultz at another cleanup project; the "Sandpoint" lease, where brine was illegally (and without NGX's consent or knowledge) dumped into an unused OXY drilling pit by a water-hauling company; Great Basin (according to OXY's photographs & Great Basin's ex-driver's sworn testimony). And as you are aware, this cleanup process is in progress.

Needless to say, for a small operator these cleanups take a big part of NGX's time and money to handle. I do appreciate your patience to date.

#### Dear Operator:

On April 4, 2007, Oil Conservation Division ("OCD") Deputy Oil and Gas Inspector Phil Hawkins inspected the well site for the NGX Company ("NGX") well identified above. During his inspection he observed a large area of oil on the ground. An open ended 2 inch steel line from the heater had allowed oil to escape from the heater and flow out onto the ground. Photographs of the inspection are enclosed.

OCD Rule 19.15.1.13 NMAC ("Rule 13") prohibits the waste of oil and gas during general operations. The wasting of oil or natural gas during general operations is a violation of Rule 13. OCD Rule 19.15.3.116 NMAC ("Rule 116") requires OCD to be notified of any unauthorized release and for such release to be remediated in accord with OCD requirements and standards. The non-notification of an unauthorized release and non-clean-up of an unauthorized release is a violation of Rule 116.

On April 4, 2007, Inspector Hawkins sent NGX a Letter of Violation (LOV No. 029707) which informed NGX that it was in violation of Rule 13 and Rule 116. Inspector Hawkins asked NGX to "[p]lease submit a Form C-141 to the OCD District 2 office no later than April 19, 2007. In addition, please submit a work plan proposal for clean up/remediation of this release no later than May 4, **2**007. The work plan proposal is to be formulated based on site ranking, contaminant delineation, and NMOCD Rules and Guidelines."

On April 20, 2007, OCD received NGX's Form C-141.

On April 23, 2007, OCD Deputy Oil and Gas Inspector Mike Bratcher sent NGX a letter which informed NGX that OCD was denying NGX's Form C-141 because it was not signed and did not appear to report the correct volume of release. Inspector Bratcher asked NGX to re-submit a Form C-141 with this information by May 14, 2007.

On August 21, 2007, OCD Deputy Oil and Gas Inspector Gerry Guye emailed George Scott asking him for information on the status of NGX's new Form C-141 and remediation work plan. On August 22, 2007, Mr. Scott emailed Inspector Guy telling him that he had the Form C-141 ready to submit and that he would be submitting it on his next trip to Artesia.

On September 4, 2007, OCD received NGX's re-submitted Form C-141. OCD approved the Form C-141 with the stipulation that samples were to be taken, and a work plan prepared and approved prior to backfill of excavated area.

On September 18, 2007, Inspector Guye informed Mr. Scott in an email that OCD had not received a work plan or any analytical data from sampling. Inspector Guye asked Mr. Scott to provide this information to OCD by September 19, 2007. On September 18, 2007, Mr. Scott emailed Inspector Guye telling him that he thought Michael Schultz was handling this matter. Mr. Scott said he would check on the status first thing in the morning.

As of this date, NGX has taken no further action on this matter.

Rule 13 prohibits the waste of oil and gas. Rule 116 requires OCD to be notified of any unauthorized release and for such release to be remediated in accord with OCD requirements and standards.

NGX knowingly and willfully violated Rule 13 by allowing oil to waste. NGX knowingly and willfully violated Rule 116 by failing to notify OCD of the release or cleaning up the release, even after being advised to do so.

NGX's misconduct warrants issuance of this Notice of Violation and assessment of civil penalties pursuant to NMSA 1978, §70-2-31(A) for violations of the OCD rules described above. Section 70-2-31(A) authorizes penalties of up to **one thousand dollars (\$1,000.00)** per day per violation for any knowing and willful violation of any provision of the Oil and Gas Act or any rule adopted pursuant to the Act.

Because the rule violations at issue are serious and occurred over a period of time, the OCD believes at this time a **six thousand dollars (\$6,000)** civil penalty and a definite commitment to future corrective action are essential. The \$6,000.00 civil penalty is based on one violation of Rule 13 and five violations of Rule 116 (a \$1,000.00 for each month NGX continued to violate Rule 116).

Please contact Daniel Sanchez, OCD Enforcement and Compliance Manager, <u>within ten (10)</u> <u>days of the date of this letter</u> at (505) 476-3493, to schedule an administrative conference to discuss this matter. OCD legal counsel may be present by telephone for this conference, and you may bring legal counsel if you wish. The purpose of the administrative conference is to discuss the facts surrounding this notice of violation, and to determine if the matter can be resolved administratively through an agreed compliance order.

If this matter cannot be resolved administratively, the OCD may take further enforcement action, which may include an enforcement hearing before an OCD hearing examiner seeking an order requiring that the wells be plugged and abandoned pursuant to NMSA 1978, § 70-2-14(B). That statute provides:

If any of the requirements of the Oil and Gas Act or the rules promulgated pursuant to that act have not been complied with, the oil conservation division, after notice and hearing, may order any well plugged and abandoned by the operator or surety or both in accordance with division rules. If the order is not complied with in the time period set out in the order, the financial assurance shall be forfeited. NGX Company NOV 02-07-25 November 9, 2007 Page 4 of 4
