Describe Cause of Problem and Remedial Action Taken.*

The choke on the well was washed out from the sand and the production tank overflowed, causing the release. The wells were shut in and vacuum trucks were called to recover the released fluids.

Describe Area Affected and Cleanup Action Taken.*

The release impacted areas inside and outside of the lined berm. Oil was recovered from within the berm and the gravel is being removed and replaced. Areas outside of the berm that were impacted were scraped and soils were hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken from the areas outside of the lined berm and analysis ran for TPH & BTEX. If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 20) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. Depth to Ground Water: < 50' (approximately 45', Section 24, T24S-R27E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20.
