

Describe Cause of Problem and Remedial Action Taken.\*

The steel flow line had a hole in it, causing the release. Vacuum truck(s) were called.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 15'X 15' within the lined and bermed battery. The valves were closed and 100% of the released oil & produced water was recovered using a vacuum truck. Impacted gravel removed/hailed to a NMOCD approved facility. Depth to Ground Water: < 50 (approximately 25', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20. Based on the battery being lined/bermed all released fluids recovered, Yates Petroleum Corporation requests closure.
