The above application was originally filed administratively, but was placed on the hearing docket due to an objection by Hallwood Petroleum Inc. ("Hallwood"). Hallwood has now agreed to withdraw its objection in return for Cross Timbers moving the well further to the west. Enclosed is a letter from Cross Timbers identifying the new location (1705 feet FSL and 1285 feet FEL), and containing plats and a new Form C-102 regarding the well. Well locations are limited in this area because the well unit is in Farmington.




