Dear Mr. Jones & Mr. Lovato:

XTO Energy Inc. requests administrative approval to amend Surface Commingle Order PLC-172A to include the Ohio E Govt #1R (30-045-32871) to the Ohio Government LaPlata CDP. This well will be a new Blanco Mesaverde completion. Adding this well to the existing surface commingle will greatly enhance productivity by utilizing an existing compressor.

Gas produced shall be allocated to each lease by separately metering production from each well prior to commingling while oil production will not be commingled. The commingled natural gas production shall be delivered to the sales meter at the Ohio E Government #18-1, located in NW/4 NE/4 Section 18, Township 31North and Range 12 West.

Interest owners for this surface commingle addition are all common and identical within pools. Enclosed you will find a plat for this well which shows it is located within the same acreage as the existing surface commingle PLC-1272A, approved on July 19, 2000.
