Dear Mr. Stogner:

Burlington Resources is applying for administrative approval of an unorthodox gas well location for the Basin Dakota formation.

The subject well was staked at this location due to geology, cultural concerns and at the request of the surface land owner. Archaeology sites comprise a majority of the area to the northeast and southeast, within the legal spacing window for this formation. The San Juan 29-7 Unit 33 and 33B Mesaverde wells, to the east and south of this location, would also be affected, drainage wise, if the proposed location was moved farther east. Twinning the San Juan 29-7 Unit 507R Fruitland Coal well location was not an option, due to drainage on the two existing Mesaverde wells also. However, we propose to locate remote facilities from the 33C onto the 507R wellpad, to minimize surface disturbance for the landowner. As Burlington is the only working interest owner within this Section, this would not effect any other offset operators and/or working interest owners within this area.


This location was also staked non-standard for the Basin Dakota formation to best fit the geology and to alleviate any land owner concerns. We are not requesting non-standard approval for the Mesaverde formation, due to it being within the San Juan 29-7 Unit and within the Mesaverde participating area, as shown on the attached offset operator plat. The gas from this well is to be commingled between these two formations.




