XTO Energy Inc. hereby requests administrative approval for an unorthodox location for the above referenced well. Attached for your reference are the following exhibits:

1. Well location plat (NMOCD Form C-102)
2. Topographic map
3. Ownership map
4. Production map of Angle Peak Gallup

The above captioned well is proposed to be drilled as a Basin Dakota and Angel Peak Gallup well with the Basin Dakota being spaced as a W/2 320 acre unit and the Angel Peak Gallup as an 80 acre laydown unit in the S/2 NW/4. The primary formation for this well is the Basin Dakota formation and the well is being placed at this location due to topographic problems and to obtain the greatest distance from the JC Gordon D #2 well (existing Dakota producer in the quarter section) while attempting to be a standard location for the Angle Peak Gallup. As can be seen from the topographic map, the rugged surface conditions prevent moving the location to the north to obtain a standard location for the Angle Peak Gallup. As indicated on the ownership map, Burlington Resources Oil & Gas Co. is the only other owner and offset owner in all directions from the Angel Peak Gallup 80 acre unit.


SECTION PLAT OF 9 SQUARE MILES




