Phillip,

With chloride contamination, we have to look at several different things. OCD would prefer to see chloride impacted material cleaned up to 1000 mg/kg (ballpark figure). If a site has impact that has gone deeper than is practicable to excavate, we may consider some excavation and installation of a cap (liner). Every site is a little different, and that is how we have to approach them. The analytical data from a vertical/horizontal delineation of the impacted area is the first thing we would want to see, and go from there.

Mike,

I'm glad that I was able to talk with you briefly today. I understand that you're pretty busy right now, but I wanted to give you a brief description of the project and what I'm looking for.

My company (Kleinfelder) has been retained by Halcon to perform a follow up investigation on a salt water spill that occurred at the Beeson 'F' lease, Well # 29, in Eddy County NM. The spill occurred on 8/22/2012.

It is my understanding that at least some soil was excavated and removed from the site and that some soil samples were collected and submitted to a laboratory. However, I have not been able to track down any reports or lab results. The Incident Report states that you and Randy Dade were notified, so I was hoping you could share any information you have on that spill and subsequent clean up.

I will be making a site visit this Friday and wanted to review all known documents concerning the spill before the field visit. So if you could let me know what NM-OCD knows I would very much appreciate it.
