
Describe Cause of Problem and Remedial Action Taken.*

A check valve on a water knockout failed, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 50'X 50'. Problems with the knockout were corrected and vacuum trucks were called, recovering all of the released produced water (Battery is bermed and lined). Depth to Ground Water: 50-99' (approximately 70', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on all volumes of produced water recovered, battery is bermed and lined, Yates Petroleum Corporation requests closure.
