NMOCD District 2 office is in receipt of a proposal to delineate soils to determine the extent of contamination that may be present as a result of a release of produced fluids as referenced above. Site delineation is one of the first steps to be taken in order to formulate a remediation proposal, and does not necessarily require a formal approval, however, the request is approved. OCD does require 48 hours notification prior to obtaining any samples where the analyses will be submitted to OCD.

Delineation operations are to commence not later than July 25, 2012. A proposal for remediation of the site, based on the delineation results and specific site criteria, is to be submitted to OCD not later than August 25, 2012.

OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
