Describe Cause of Problem and Remedial Action Taken.*
A stainless steel fitting on the salt water disposal pump leaked at the connection to the ball valve releasing approximately 10bbls produced water. All valves on the stainless steel line connected to the pump were immediately closed to stop the release. The stainless steel fitting on the salt water disposal pump has been repaired.

Describe Area Affected and Cleanup Action Taken.*
The spill was approximately 10' x 15' area located on the Southwest corner of the location next to the salt water disposal pump. 10bbls produced water was released and 8bbls were recovered with no fluid leaving location. Environmental agency will be contacted for remediation.
