A static discharge fire on the gas compressor suction line caused 5 bbls of oil and 40 bbls of produced water to leak onto the ground. No fluids were recovered and the line was repaired/replaced.

The affected area is approximately 55' x 80' off location near the trench. Remediation will be completed in accordance with the remediation plan approved by NMOCD.

This is to inform you that Oxy Permian had a leak at the Cedar Canyon 16 State #8H on November 11, 2015. Oxy spilled 5 bbls of oil and 40 bbls of water due to a static discharge fire on the gas compressor suction line. The preliminary report shows the leak measuring approximately 200' x 100' off location approximately 150' east of the well. No fluids were recovered. The release is located east of U/L A of Section 16, T24S, R29E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From Carlsbad, go south on US285 to Malaga, turn left on Duarte Rd, turn right on McDonald Rd, turn left on Dogtown Rd, cross the river, turn left and follow road to 3<sup>rd</sup> right that lead to the location.
