ADMINISTRATIVE POOL/LEASE COMMINGLING ORDER

Pursuant to your application received on December 7, 2015, Breitburn Operating LP (OGRID 370080) is hereby authorized to surface commingle oil gas production from the following pools located in Township 22 South, Range 37 East, NMPM, Lea County, New Mexico;

and from diversely owned wells identified in Attachment No. 1, and made part of this order. These wells are located on New Mexico State Lease B-934 in Township 22 South, Range 37 East, Lea County, New Mexico.

All wells, except the Encore M State Well No. 9 have identical ownership; therefore within this application, there are two leases, per agreement.

The commingled oil production for the Encore M State Well No. 2, Encore M State Well No. 3, Encore M State Well No. 4, Encore M State Well No. 5, Encore M State Well No. 6, Encore M State Well No. 7, Encore M State Well No. 8, Encore M State Well No. 9, Encore M State Well No. 10, and Encore M State Well No. 12 shall be metered with a combination of well testing and allocation meters at the M-State Satellite No. 1 central tank battery (CTB) located in Unit G, Section 19, Township 22 South, Range 37 East, Lea County, NMPM, New Mexico. The gas production for these wells shall be metered and sold at the M-State Satellite No. 1 CTB. The commingled oil production for the Encore M State Well No. 14, Encore M State Well No. 15, and Encore M State Well No. 16 shall be measured with a combination of well testing and allocation meters at the M-State Satellite No. 2 central tank battery (CTB) located in Unit A, Section 30, Township 22 South, Range 37 East, Lea County, NMPM, New Mexico. The gas production for these wells shall be metered and sold at the M-State Satellite No. 2 CTB. The oil and gas

production for the Encore M State Well No. 19 shall be continuously metered separately. The commingled oil production then flows to the Encore M State central tank battery (CTB) where it is sold, located in Unit N, Section 30, Township 22 South, Range 37 East, Lea County, NMPM, New Mexico.

The allocation meter shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

All parties owning an interest in the subject wells have waived objection.

The surface commingling facility is an active facility; however, the addition of the Devonian pool and the change in ownership necessitated the pool lease commingling application.

Subsequently drilled wells that produce from the subject pool within the project areas approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.

The operator shall notify the transporter of this commingling authority.

The operator shall notify the Hobbs District Office upon commencement of commingling operations.
