**Describe Cause of Problem and Remedial Action Taken.\***

Frac tanks at the Trionyx Treatment Facility overflowed due to human error causing a spill of 56 barrels of produced water to overflow inside the lined containment. Pumps were shut down at the batteries to stop the overflow.

**Describe Area Affected and Cleanup Action Taken.\***

56 barrels of produced water overflowed inside the lined containment at the Trionyx Treatment Facility. Liner was checked for holes and no holes were found; therefore the spill did not touch the pad or leave the lease. A vacuum truck was used to recover the entire spill of 56 barrels of produced water.
