


Describe Cause of Problem and Remedial Action Taken.\* Unlined pit used by previous operator (Windmill Oil Company) for which ExxonMobil (XTO) was identified by BLM as a previous lease operator and contacted for cleanup. Initial soil samples collected in accordance with closure plan approved by OCD Santa Fe (Brad Jones) exceeded TPH reporting limits under pit rule (June 28, 2013) and requires notification to OCD District 1.

Describe Area Affected and Cleanup Action Taken.\* Lateral and vertical extent of contamination was delineated and Initial C-141 approved by OCD District 1 on January 30, 2014. Cleanup action was completed including excavating soil between approximately 8 and 10 feet below ground surface (bgs) for disposal a OCD approved facility, Jay Dan Landfarm, installing 20 mil polyethylene liner, with padding soil above/below liner, filling with caliche to between 3 and 4 feet bgs and remainder of excavation with topsoil. Surface reclamation will be according to plan approved by OCD Santa Fe on October 22, 2013.
