A flow line ruptured causing a spill. Lease operator shut off electronic submersible pump and closed valves to prevent further release. The flow line has been repaired.

Describe Area Affected and Cleanup Action Taken.*

A flow line ruptured causing a release of approximately 48 BBL of produced water and 5 BBL of oil. The spill occurred off pad in a 60' x 15' area on the northeast side of the Cooter 16 State Com 5H well pad. A vacuum truck recovered approximately 45 BBL of produced water and 5 BBL of oil. An environmental agency will be called out for remediation.
