
Describe Cause of Problem and Remedial Action Taken.\*

A 6" steel pipeline was struck by a contractor causing liquids and an overspray of crude oil with a mixture of produced water to impact the soil in the area.

Describe Area Affected and Cleanup Action Taken.\*

Area impacted was a radius of 2000x650. Micro-blaze was applied with a surfactant to loosen the hydrocarbon impaction of the impacted soils. An environmental consultant will remediate this site per NMOCD regulatory standards and the landowner was notified of the release.
