

Devon Energy Production Company, L.P. ("Devon") plans to drill the referenced horizontal well to an approximate total vertical depth of 11,201' and an approximate total measured depth of 20,501' in order to test the Second Bone Spring Sandstone formation. As reflected on the attached C-102, the well has been permitted at a surface location of 225' FNL & 1,450' FWL Section 14-T24S-R33E with a permitted bottom hole location of 330' FSL & 1,450' FWL of Section 23-T24S-R33E. The projected upper perf is expected to be approximately 330' FNL & 1,450' FWL Section 14-T24S-R33E and the projected lower perf is expected to be approximately 330' FSL & 1,450' FWL Section 23-T24S-R33E. The reason behind permitting this well at an unorthodox location is to maximize recovery.

In accordance with Division rules, Devon respectfully requests that the Commission administratively approve the enclosed application for an unorthodox location with respect to that portion of the horizontal wellbore as described in the above paragraph.


