Describe Cause of Problem and Remedial Action Taken.*

This release was caused by a surface casing valve left open to a line that dumped into the water tank causing it to run over. A vacuum truck was dispatched to remove all free standing fluids.

Describe Area Affected and Cleanup Action Taken.*

Initially 1bbl of oil and 35bbls of produced water were released due to a surface casing valve left open to a line that dumped into the water tank causing it to run over. The valve was closed to prevent this from occurring again. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
