All wells are producing from the Lost Tank Delaware, West pool and BLM interest is identical in both leases at 12.5%.

**Oil & Gas metering:**

Oil, water and gas production from all wells listed above will be individually tested at Lost Tank 3 Federal #5 CTB located at H-3-22S-31E using a three phase test separator. All wells will be tested monthly for allocation purposes using oil meter (S/N 84743) and gas meter (S/N 83261T). Before leaving the lease, gas will be metered using Oxy check meter (S/N 83261), located on lease. OXY USA Inc requests check meter to be utilized as FMP.

Total oil production will be sold via LACT unit (S/N 3143877), located at the Lost Tank 3 Federal #5 CTB.

Produced water will be measured through a turbine meter (S/N 84765) and transferred via pipeline and disposed of at Lost Tank 33 #2 SWD and Lost Tank 3 #25 SWD.


**Process and Flow Descriptions:**

The flow of production is shown in detail on the enclosed facility diagram.

The commingling of this production is the most effective means of producing the reserves and will not result in reduced royalty or improper measurement of production. The proposed commingling will reduce the surface facility footprint and overall emissions.

OXY USA INC understands the requested approval will not constitute the granting of any right-of-way or construction rights not granted by the lease instrument. These applications will be submitted separately for approval per NMOCD and BLM regulations.


