Mr. Cooper:

Reference is made to your request, dated April 2016 (date stamped by Division on May 2, 2016), on behalf of Oasis Water Solutions, LLC for an extension of the June 30, 2016, deadline to commence injection into the above named well for reasons outlined in the attached correspondence.

It is the Division's understanding from your request that there have been no significant changes in the information provided in the application submitted for review and approval of this order. These changes include the completion of new wells within the Area of Review (AOR) that penetrated the approved injection interval and any changes in ownership for the affected persons noticed in the original application.

The Division finds that granting this request to extend this administrative order is in the interest of conservation, will prevent waste, and will protect the environment.

All requirements of the above referenced administrative order and agreements in the application remain in full force and effect.

The deadline to commence injection for the existing order is hereby extended until June 30, 2017.

If the Operator cannot commence injection by this deadline, the Operator may petition for an additional extension by submitting a written request (prior to the expiration of this extension's deadline date) that includes a determination for any new wells in the AOR and a statement on the *current status of ownership for affected persons noticed in the original application*.

Mr. Catanach:

Oasis purchased three wells from MNA Enterprises in January 2015, MTS #2, MTS #3 and the Pearl State #2, all for the purpose of converting to SWD. The MTS #2 and the Pearl State #2, SWD 1542, have been approved and we have been working at building a new unloading facility and getting right-of-way permits and contracts from State Land Office and private land owners. The facility is completed and the Pearl State #2 was converted to injection, starting July 2015.

Sometime in August or September of 2015, the oil and gas industry took a severe downfall and the disposal service severely declined. We are still working to convert the MTS #2 and will, our problem is we are running out of time. We have our right-of-way permit, we have ordered pipe, but the company can't guarantee delivery and the oil industry is still in an "economic mess".

Oasis is requesting an extension to its MTS #2 conversion and would appreciate your consideration. We look forward to hearing from you.
