Describe Cause of Problem and Remedial Action Taken.*

On May 3, 2011, A BLM inspection of the site discovered a flowline leak in the road. A surface inspection form was submitted. On October 20, 2011, a second inspection of the site resulted in a secondary surface inspection form submitted.

Describe Area Affected and Cleanup Action Taken.

On June 23, 2016, DFSI personnel were on site to obtain samples within both of the leak areas. Within the release area, five samples were obtained and field sampled for chloride levels, as well as BTEX. The BTEX samples were performed using a Mini Rae Photoionization Detector (PID). All clean field samples under NMOC and BLM regulatory guidelines were submitted for laboratory analysis at Cardinal Laboratories of Hobbs, NM to obtain confirmation; resulting in concentrations that decreased with depth.
