Thank you for responding quickly. Just got out of our meeting. Here is the calculations on the spill. I will submit a C141 for this spill today.

Within Containment:

- Total: 10.68 bbls of fluid
- Oil: 0.58 bbls (based on latest well test of 85 bbls water and 5 bbls oil)
- Water: 10.1 bbls

Outside Containment:

- Total: 0.9 bbls of fluid
- Oil: 0.05 bbls (based on latest well test of 85 bbls water and 5 bbls oil)
