

Describe Cause of Problem and Remedial Action Taken.* rock lying to close to p/l when installed and eventually rubbed hole on side of pipeline. Pipeline was shut in at Sta. 11, backhoe was called in to excavate leak area, WEE Inc./ET of NM called to document leak.

Describe Area Affected and Cleanup Action Taken.* water ran from the leak source on the w. side of pipeline total distance 464'L x 34'W, and also to the east side of the pipeline 136' x 152'. Total approx. sqft is 32,132. TBS was called in to immediately start haul off of material. NMSWD will be slip lining the existing pipeline with a new poly line to help prevent future line leaks. WEE Inc. / ET of NM has been contracted for delineation of site.
