


Describe Cause of Problem and Remedial Action Taken.* BOPCO EHS was notified of a release that occurred at the Big Sinks 2-25-30 Battery (PLU CVX JV BS 007H), fluid was released due to suction screens being plugged up causing tanks to run over into impervious containment. All fluid remained inside the lined containment with the exception of a light mist in front of the lact area.		
Describe Area Affected and Cleanup Action Taken.* A vacuum truck was called to the location and recovered the fluid from the impervious containment (150 barrels). The light misted area will be scraped up and hauled to disposal.
