Dear Mr. Leking:

Cheryl Winkler with Mosser Corporation, an environmental regulatory company, is doing work for Range Operating New Mexico, LLC. ("Range") as to the reclamation and regulatory compliance related to the referenced well, well pad site and roads accessing same. D. K. Boyd is the surface estate owner of the referenced well site. Cheryl has asked that I confirm in writing to the Oil Conservation Division ("OCD") the following:

- 1. We have instructed Range to use a specific seed blend for their reseeding and revegitating operations on all our lands in the subject site's area, a copy of which is enclosed.
- 2. As to the access road coming onto our property through a cattle guard, on our fence line near the subject site, we have instructed Range to leave the road in place running from the cattle guard to the point at which it intercepts the DCP meter run. The rest of the road accessing the referenced site is to be removed and the road bed remediated, reseeded and revegitated as should be the referenced well site, pad, pit area and or any other areas disturbed by Range's operations related to this referenced well.
