The 1" poly gas line did not have a regulator on the line which allowed the pressure to build up too high causing the line to rupture leaving a 2" hole in the line. The valves were closed on the line to isolate the line and stop the release. A regulator was added to the line and part of the line has been replaced. The repaired line is back in service.

Describe Area Affected and Cleanup Action Taken.\*

Approximately 211 MCF natural gas was released with 0 MCF recovered. No further action is required.
