A compromised water transfer line leaked 65 bbls of produced water into the pasture north of location. A vacuum truck recovered 50 bbls of produced water and the line was repaired.

The affected area is approximately 125' x 45' just north of location in the pasture. Remediation will be completed in accordance with a remediation plan approved by both NMOCD and the BLM.
