In order to optimize production in the well, it is proposed to unset the packer, pull tubing, cleanout to PBTD if needed and run tubing allowing the MV to be commingled with the already commingled GALLUP and DK.

Basic Job Procedure:

1. Unset Packer
2. Pull Tubing
3. Clean Out to PBTD (if needed)
4. Run Tubing without packer
5. Install bottom hole bumper spring and plunger
6. Return Well to production







Commingle Allocation Calculations

OIL

Since this gas well was 1st delivered in June 1985, neither pool has made any oil. However, since the Basin Dakota pool does produce oil and the Laguna Seca Gallup pool does not, we allocate any future oil to the Dakota pool.

GAS

Both the Laguna Seca Gallup pool and the Basin Dakota pool are currently declining at the same 4.5% exponential decline rate. See attached production curves. Using the decline rate of 4.5%, the forecast from the attached curves indicates a Gallup producing rate of 6 MCF/D and the Dakota rate of 160 MCF/D at the end of 2008.

Total gas is $6 + 160 = 166$ MCF/D

$$\% \text{ GALLUP} = \frac{6}{166} = 4\%$$

$$\% \text{ DAKOTA} = \frac{160}{166} = 96\%$$




