BOPCO EHS was notified of a release that occurred at the PLU 78, storms in the area knocked out power to the battery causing water system tanks to fill and run over. The fluid filled the containment and overflowed to the ground surface. Vacuum trucks were called to the location and recovered 2210 barrels from the containment and ground surface combined.

Describe Area Affected and Cleanup Action Taken.\*

Vacuum trucks were called to the location and recovered 2210 barrels from the containment and ground surface combined. An initial response crew was dispatched to the site and began scraping up the saturated surface soil.
