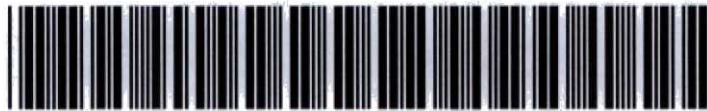

Williams proposes to excavate and implement soil shredding to remediate approximately 1,500 cubic yards of hydrocarbon impacted soil. The impacted soil will be excavated to determine the final extents of hydrocarbon impacts. The soil shredding consists of processing impacted soil mechanically, followed by the application of hydrogen peroxide to oxidize the hydrocarbons. The soils will be sampled and laboratory analyzed for total petroleum hydrocarbons (TPH) and benzene, toluene, ethyl benzene and xylenes (BTEX) to determine if contaminant concentrations are at or below the site ranking criteria for use as backfill. Upon meeting or exceeding the site criteria for contaminant concentrations, the treated soil will be placed in the excavation as backfill material. The current estimate is 2 weeks to complete this process.
