The commingled oil and gas production from the wells detailed above shall be measured and sold at the Riverbend B11 Central Tank Battery (CTB) located at the Riverbend Federal Well No. 7 well pad located in Unit E, Section 23, Township 24 South, Range 29 East, Eddy County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from the diversely-owned wells and leases shall be measured using well testing.

The production from each well, except the Cedar Canyon 22 Well No. 1H in which the gas is continuously metered at the well head, will flow through an header onto a two phase separator to separate the gas from the liquids. Liquids will then flow through a heater treater to separate oil water, and the remaining casing head gas. Each of these low production wells will be tested a minimum of once per month.

The operator shall notify the transporter of this commingling authority.

The operator shall notify the Artesia District Office upon commencement of commingling operations.

This approval is subject to like approval from Bureau of Land Management before commencing commingling operations.
