The combined project area for these wells include the entire Section 16, Township 20 South, Range 34 East, NMPM, Lea County, New Mexico.

The commingled gas production from the wells detailed above shall be measured and sold at the Quail 16 Central Tank Battery (CTB) located at the Quail 16 Well No. 2 located in Unit N, Section 16, Township 20 South, Range 34 East, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The gas production from each diversely-owned wells and leases shall be continuously metered as follows:

The Quail State 16 State Com. No. 3H and Quail State 16 State Com. No. 4H shall each have their own 2 phase separator which shall meter the gas production. The Quail State 16 State Com. No. 7H and Quail State 16 State Com. No. 8H shall have their own 3 phase separator, which shall measure the gas production. The Quail State Well No. 1 shall be metered at the well head prior to commingling. After the gas is measured, the gas shall be commingled and then metered at the CDP.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

The operator shall notify the transporter of this commingling authority.

The operator shall notify the Hobbs District Office upon commencement of commingling operations.

This approval is subject to like approval from the New Mexico State Land Office before commencing commingling operations.
