Commingled oil and gas production from the wells shall be measured and sold at the SB State Tank Battery (CTB), located in Unit E of Section 2, Township 18 South, Range 27 East, NMPM, Eddy County, New Mexico.

The oil and gas production from the diversely owned wells and leases, with the exception of the TDF State Well No. 2 shall be metered with a combination of metering and testing. The TDF State Well No. 2 shall be metered separately, before commingling.

The allocation meters shall be calibrated quarterly in accordance with Division Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations.

The producer/Operator shall notify the transporter of this commingling authority and the Artesia District Office prior to implementation of commingling operations.

This Order supersedes Administrative Order PLC-207-B, issued on July 20, 2004. This amended administrative order allows for well testing and metering of wells and leases, whereas the previous order required individual metering of wells and leases.

This approval is subject to like approval from the New Mexico State Land Office before commencement of the commingling operations.
