Reference is made to your request on behalf of Fasken Oil and Ranch (the "operator") to extend the April 23, 2017 deadline stipulated in order SWD-1537 to commence injection operations for the above referenced well for an additional one year for reasons outlined in the attached correspondence.

These changes include the completion of new wells within the Area of Review that penetrated the approved injection interval and any changes in ownership.

Fasken Oil and Ranch, Ltd. is requesting an extension for the subject salt water disposal permit for 1 year from its up-coming expiration date of April 23, 2017. Fasken has drilled the subject well, but is still waiting on the New Mexico State Land Office for a Salt Water Disposal Easement to use the well. Our application to the NMSLO has been on file since October 2016. We are ready to begin disposal into the subject well as soon as the NMSLO gets the SWD Easement finalized and to us.

Conditions as submitted in the original SWD application are the same. No additional well work has been done that would impact our permit.
