*The pipeline was inadvertently struck by heavy equipment during excavation activities associated with the construction of another pipeline not owned or operated by Energy Transfer. Approximately 8 oil wells were shut in in response to the strike. Repairs to the pipeline were completed on 05/19/2017 and the wells brought back online. The pipeline was leaking only field natural gas no impacts to soil were observed.*
