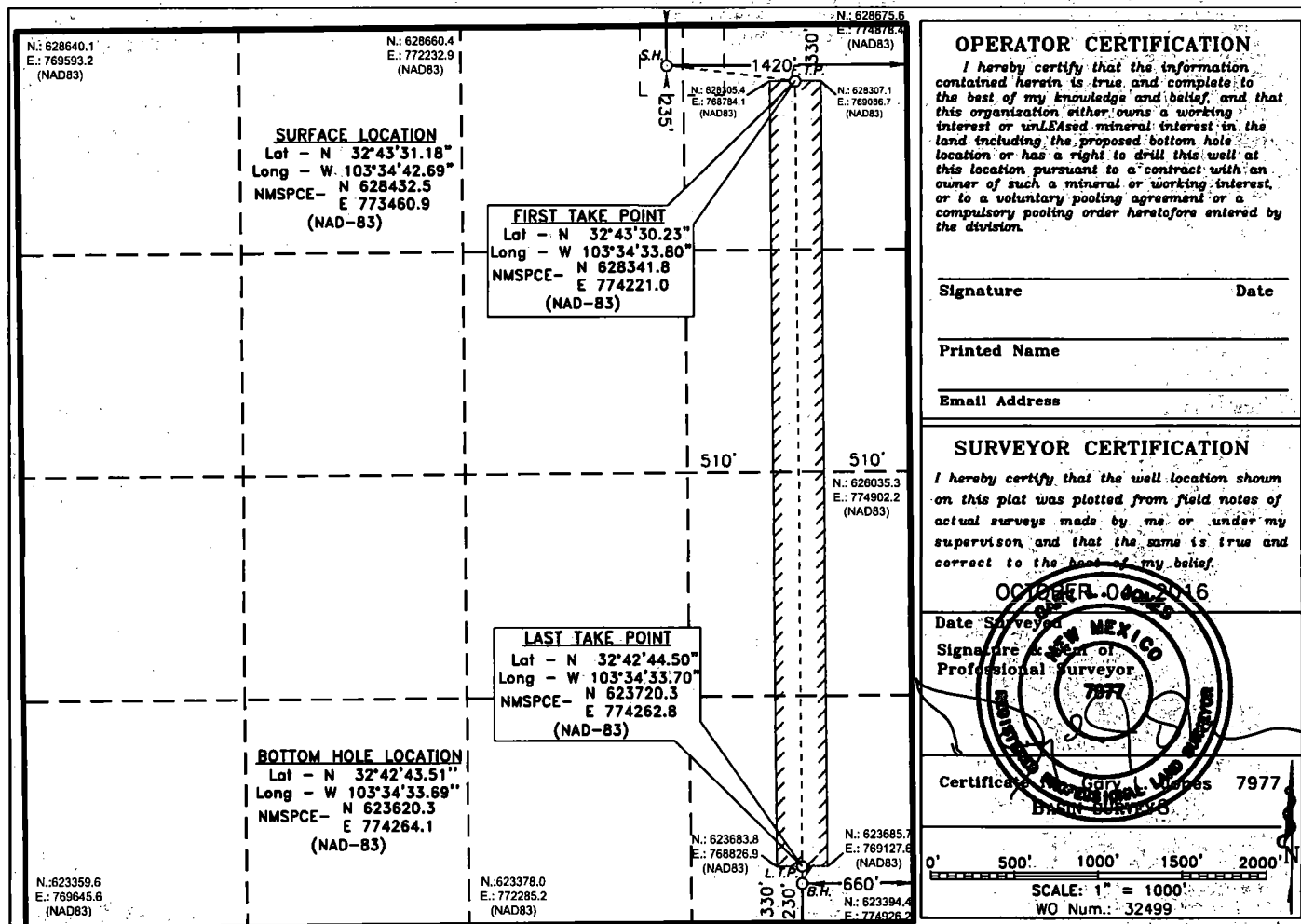

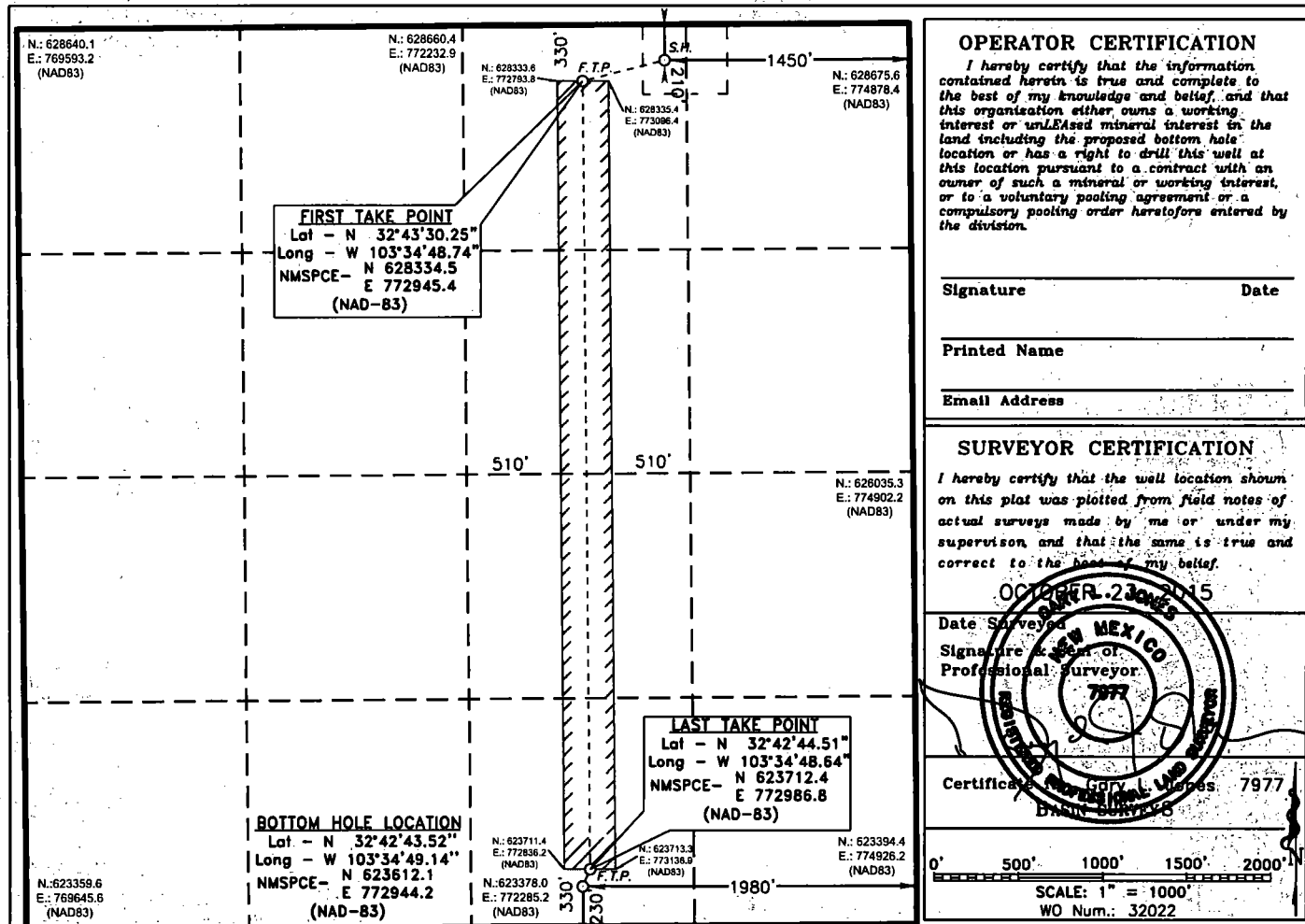

These are proposed totals for these wells; once these wells are drilled the production information will be amended. I will submit production volumes for the EK 29 BS2 Fed Com 1H & 2H upon receipt.

Attached map displays the federal leases and well locations in NENE Sec. 29-T18S-R34E.

Although the Federal royalty rate is the same in both wells (Federal Lease NMNM0245247 and NMNM012277 is 12.5%); there is a 25% private mineral interest in the SESE Sec. 29 T18SR34E associated with the EK 29 BS2 Fed Com 1H well.

Even though the mineral ownership in both wells is different, McElvain Energy Inc. is confident that commingling these wells is in the best interest of the public and meets the requirements set forth in 43 CFR 3173.14 for approval of a CAA.

43 CFR 3173.14 states;

"(2) The operator or operators must provide a methodology acceptable to BLM for allocation among the properties from which production is to be commingled (including a method for allocating produced water), with a signed agreement if there is more than one operator;

(3) For each of the leases, unit PAs, or CAs proposed for inclusion in the CAA, the applicant demonstrates to the AO that a lease, unit PA, or CA proposed for inclusion is producing in paying quantities (or, in the case of Federal leases, capable of production in paying quantities) pending approval of the CAA; and

(4) The FMP(s) for the proposed CAA measure production originating only from the leases, unit PAs, or CAs in the CAA."

Overriding considerations for CAA approval include:

1. Reduced surface disturbance to public lands where additional measurement and production related equipment necessary to achieve non-commingled measurement would have to be located reducing impacts to special status species such as the Lesser Prairie Chicken and the Sand Dunes Lizard.
2. The ability to access and develop all of the available oil and gas resources in the final 25% of the horizontal lateral in the EK 29 BS2 Fed Com 1H well thus reducing the possibility of stranding valuable resources.

Allocation Methodology:

The central tank battery is located on the shared pad for the EK 29 BS2 Fed Com 1H & 2H located in NENE Sec. 29-T18S-R34E. The production from each well will have its own three phase metering separator with Coriolis to meter the oil, flow meter to meter the water and gas orifice allocation meter to meter the gas. VRU gas production will be allocated back to each well utilizing each wells monthly oil production.

The EK 29 BS2 Fed Com 1H & 2H will have four oil tanks that all wells will utilize and they have a common Targa Central Delivery Point (number to be provided upon receipt) meter which is located on the southeast corner of the location. Oil, gas and water volumes from these wells producing to this battery will be determined by using an individual metering separator per well.

EK 29 BS2 Fed Com 1H production flows to its own three phase metering separator, where after separation gas is routed to the gas orifice allocation meter (number to be provided upon receipt) then to the common Targa Central Delivery Point (number to be provided upon receipt) meter. Produced water and oil are separated; the oil is then metered with a Coriolis meter (number to be provided upon receipt) and combines with the other well's oil into a common heater treater, then into a common production line and to one of the 1000 bbl oil tanks. The water is metered using a flow meter and then flows into a common produced water line and to one of the 1000 bbl produced water tanks. Oil will be sold by truck loadout using manual tank gauging (numbers to be provided upon receipt).

EK 29 BS2 Fed Com 2H production flows to its own three phase metering separator, where after separation gas is routed to the gas orifice allocation meter (number to be provided upon receipt) then to the common Targa Central Delivery Point (number to be provided upon receipt) meter. Produced water and oil are separated; the oil is then metered with a Coriolis meter (number to be provided upon receipt) combines with the other well's oil into a common heater treater, then into a common production line and to one of the 1000 bbl oil tanks. The water is metered using a flow meter and then flows into a common produced water line and to one of the 1000 bbl produced water tanks. Oil will be sold by truck loadout using manual tank gauging (numbers to be provided upon receipt).

Oil production will be allocated on a daily basis based on the well's individual Coriolis meters. These meter will be proven, as per API, NMOCD and BLM specifications, when installed, once per month for the first 3 months (to establish a consistent repeatability factor), and then quarterly thereafter, the factor obtained will be used to allocate the production volumes. Oil from both wells will then commingle into a common heater treater then into a common production line and to one of the 1000 bbl oil tanks. Oil will be sold by truck loadout using manual tank gauging (numbers to be provided upon receipt). Gas production will be allocated on a daily basis based on the subtraction method from the common Targa Central Delivery Point (number to be provided upon receipt) meter and the well's individual gas orifice allocation meters. The gas production from the VRU and the well's individual gas orifice allocation meters will commingle and flow through the common Targa Central Delivery Point (number to be provided upon receipt) meter on the southeast corner of the location. These meters will be calibrated on a regular basis per API, NMOCD and BLM specifications. The BLM & OCD will be notified of any future changes in the facility.

Process and Flow Descriptions:

Please see the proposed facility diagram for the EK 29 BS2 Fed Com 1H & 2H location. The proposed commingling is appropriate based on the BLM's guidance in IM 2013-02. The proposed commingling will maximize the ultimate recovery of oil and/or gas from the federal leases and will reduce environmental impacts by minimizing surface disturbance and emissions. The proposed commingling will reduce operating expenses, as well as, not adversely affect federal royalty income, production accountability, or the distribution of royalty.

McElvain Energy Inc. understands the requested approval will not constitute the granting of any right-of-way or construction rights not granted by the lease instrument.

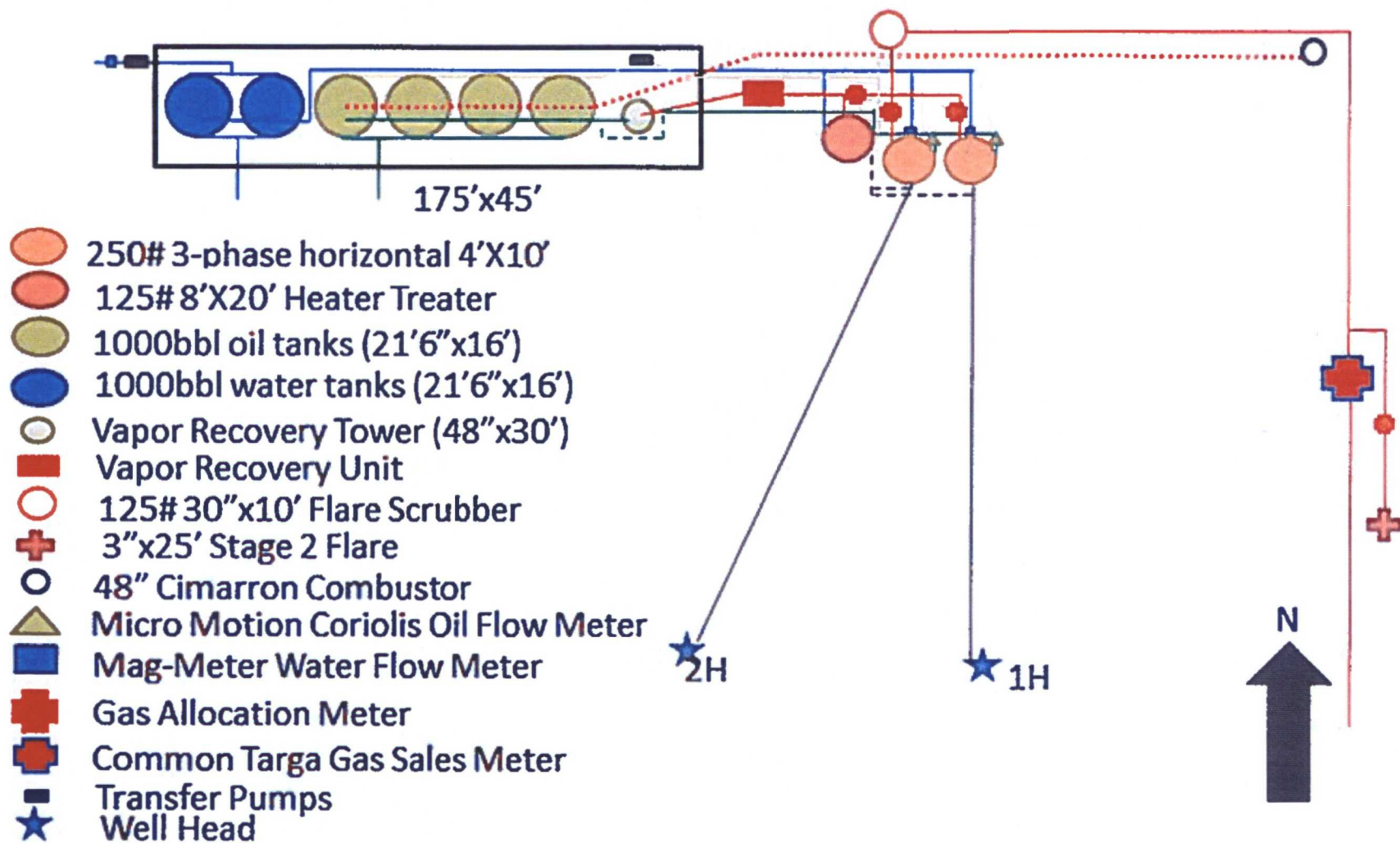


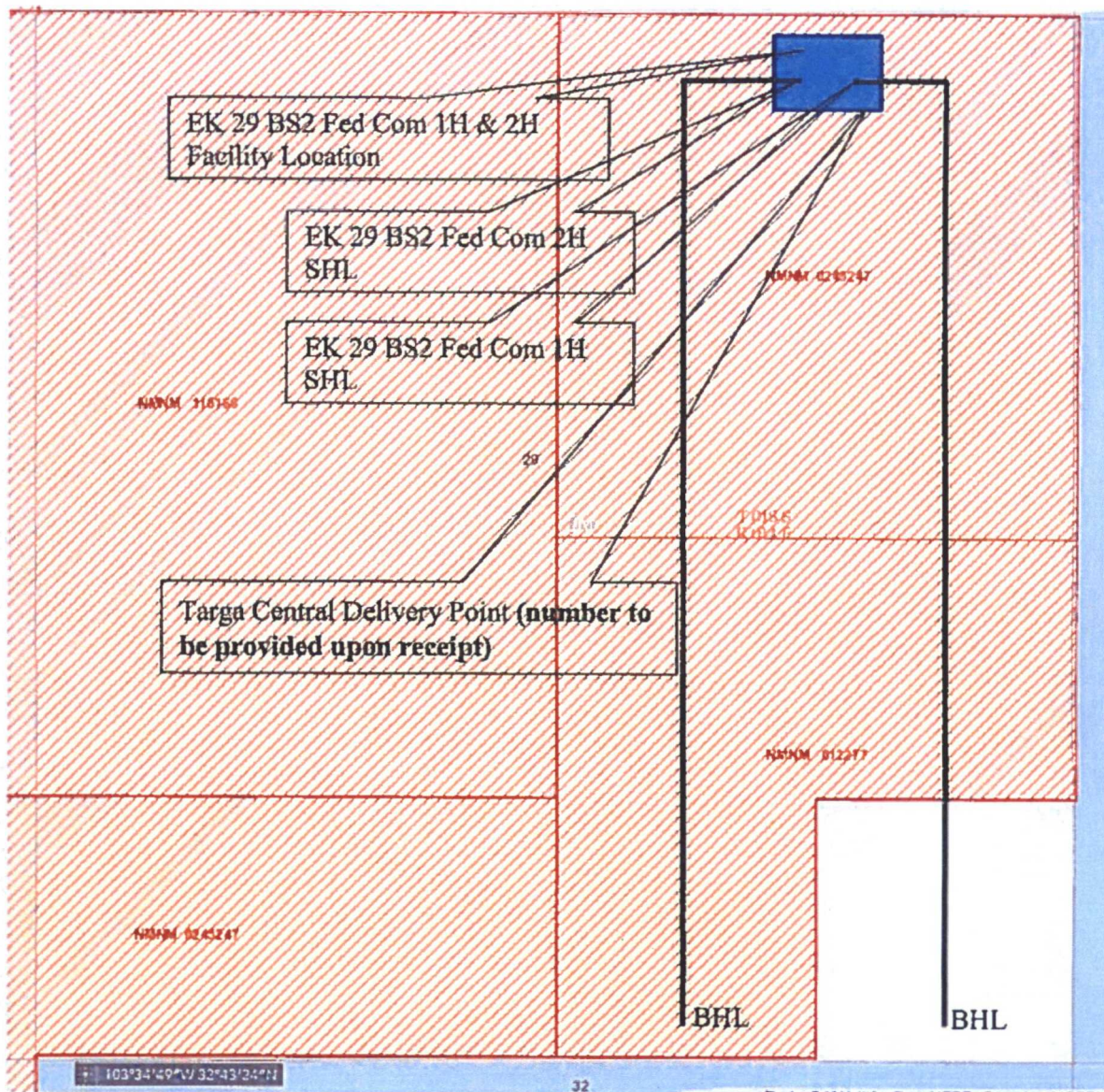
