The commingled oil and gas production from the wells detailed above shall be measured and sold at the Apache 25 Federal Well No. 6 Tank Battery (CTB) located in Unit P, Section 25, Township 22 South, Range 30 East, Eddy County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from each of the identically-owned leases shall be measured with a combination of well testing and metering. Each well shall be tested at least once a month through the dedicated tester.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

After initial notification, future wells that will produce from the pools and leases approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.

Your application has been duly filed under the provisions of Division Rules 19.15.12.10 C (4) NMAC and 19.15.4.12.A (8) NMAC. No notice is required, because ownership is identical throughout the surface commingle application.

The operator shall notify the transporter of this commingling authority.

This Order supersedes Administrative Order PLC-311, issued on July 30, 2008. This Order adds the Apache 25 Federal Well No. 17 H, and the corresponding Los Medanos; Bone Spring Pool.

The operator shall notify the Artesia District Office upon commencement of commingling operations.

This approval is subject to like approval from the Bureau of Land Management before commencing commingling operations.
