

Dear Mr. Stogner:

Marbob Energy Corporation respectfully request administrative approval for an unorthodox location of the Rocket Federal #1 well as referenced above. Attached is an OCD Form C-102 showing the proposed oil well spacing unit along with a map showing the proposed spacing unit, all offset proration units and the affected proration unit. The affected spacing unit is operated by Pogo Producing Company. Additional owners in that proration unit are Yates Petroleum Corporation, Pitch Energy Corporation and Marbob Energy Corporation. Additional owners in the proposed proration unit are Southwestern Energy Corporation. All of the remaining offset spacing units are owned by that group. A copy of this full application has been sent to each party as shown on the attached notice letter. A copy of the green cards will be forwarded to you when we receive them back from the parties. The royalty in each proration unit is the USA; a copy of this application has been forwarded to them for their files.

Marbob proposes to drill this well to test the Delaware with a vertical pilot hole. After logging and evaluating the potential productive horizons, Marbob proposes to plug back in the Delaware formation and kick off the well in a northly direction building a horizontal curve. The curve will take the bottom hole location to approximately 566' FSL and 600' FEL where we encounter the productive horizon. We then plan on drilling horizontal to a final location which well not exceed 2310' FSL and will be somewhere between a 330' FEL and 990' FEL. Production casing will be run to total depth. Completion will consist of perforating the horizontal interval and stimulating with treatment. No perforations will be at an unorthodox location, and no perforations will be in the vertical section.

The unorthodox surface location will allow for a longer horizontal lateral within the orthodox limits of the productive horizon.

If after drilling the pilot hole it is determined that the productive horizon is too marginal to warrant a horizontal well bore then the pilot hole will be plugged back up into the Delaware and deviate to the north back down to the productive horizon at a location at least 330 feet from the south line. Production casing would be run. The well would be perforated and treated. No perforations will be at a location less than 330' FSL. As such under either scenario there will be no encroachment of rights of the affected spacing unit.
