The cause of this spill is equipment failure. There was trash in the fly gas system on the heater treater preventing water from dumping into the tank. Therefore, both water and oil was dumping into the oil tank and overfilled it by ~5 bbls. All of the fluids were recovered. The containment liner was inspected immediately after the spill occurred. Based on the inspection, there is no evidence that the spilled fluids have left the containment.

Describe Area Affected and Cleanup Action Taken.\*  
The environment was not impacted by this spill. All fluids were contained inside lined SPCC containment.
