#### Dear Mr. Harrington:

Reference is made to your request on behalf of Mewbourne Oil Company (the "operator") to extend the deadline stipulated in order SWD-1591 based upon the approval date of October 28, 2015, to commence injection for the above referenced well for an additional one year for reasons outlined in the attached correspondence.

Hi Phil:

I checked the ½ mile radius and there are not any new wells that have been drilled since the original permit was approved.

I have found one commercial SWD completed in the Delaware that is within the ½ mile radius and the operator was not notified during our original application. Would they be considered an affected party?

The reason why I'm asking this is because there is a upcoming hearing where there are two SWD operators trying to drill Devonian wells in the same section. Operator 1 had an approved SWD and drilling permits before Operator 2 filed for a new SWD permit within ½ mile. I talked to Mike about this case and he told me that Operator 2 is not required to send a copy of the permit application to Operator 1.
