Mack Energy Corporation (OGRID 13837) is hereby authorized to transport and measure oil and gas production off-lease, from the following well which produces from the Round Tank; San Andres Pool (Pool code 52770) in Chaves County, New Mexico:

Description : SW/4 SE/4 of Section 23, W/2 E/2 of Section 26, and W/2 NE/4 of Section 35, all in Township 15 South, Range 28 East, Chaves County, New Mexico
Well: Klondike State Com Well No. 1H 30-005-64295

The project area for this well comprises the SW/4 SE/4 of Section 23, the W/2 E/2 of Section 26, and the W/2 NE/4 of Section 35, all in Township 15 South, Range 28 East, Chaves County, New Mexico.

The oil production from this well shall be measured at, and sold from, Klondike Central Tank Battery located in Unit H, Section 26, Township 15 South, Range 28 East, NMPM, Chaves County, New Mexico.

The commingled gas production from the well detailed above shall be measured and sold at the DCP gas meter ("Custody Transfer Point") located in Unit N, Section 19, Township 15 South, Range 29 East, NMPM, Chaves County, New Mexico.

All meters for the above-referenced well shall be physically separated from facilities for other wells, so that production from the above-referenced well will not be commingled prior to measurement with production from any other wells.

The surface commingling of oil and gas with production from other pools or leases is NOT authorized.
