Dear Mr. Campanella:

Reference is made to your request on behalf of Judah, LLC (the "operator") to extend the deadline stipulated in order SWD-1533 based upon the approval date of March 4, 2015, to commence injection for the above referenced well for an additional one year for reasons outlined in the attached correspondence. This written request for extension was submitted to the Division on March 1, 2017, then followed by a second correspondence on March 13, 2017.


It is the Division's understanding from your request that there has been only one significant change in the information provided in the application submitted for review and approval of this order. This change included a transfer in lease ownership for one party, BOPCO LP, identified as an "affected person" in the original application. The operator has provided proof of notification to the current lease owner, XTO Energy, Inc.

The operator did not find any new wells within the Area of Review that were completed after the approval date of the order and penetrated the approved injection interval.

The Division finds that granting this request to extend this administrative order is in the interest of conservation, will prevent waste, and will protect the environment.

The deadline to commence injection for the existing order is hereby extended until March 4, 2018. All requirements of the above referenced administrative order and agreements in the application remain in full force and effect.

Mr. Campanella:

The Division is in receipt of your written request for an extension of order SWD-1533 prior the expiration date of March 4, 2017 to commence injection. The extension will be processed in the next few days, but the Division does request that you provide a supplemental correspondence (via e-mail or USPS) that states 1. The applicant has reviewed the current ½-mile AOR and found no new wells that penetrate the injection interval (Devonian) and 2. The noticed affected persons (including surface owner) of the original application have not changed since the order was approved. Addressing these two items will avoid any potential regarding the order's legitimacy at a future date once the extension is issued. I would also request that you review the extension period (six months) and make sure this is sufficient time to provide Judah with ample time to get online. Thank you. PRG

Judah Oil, LLC ("Judah") wishes to notify XTO Energy Inc. ("XTO") of our intentions to re-enter and convert the Pronghorn Federal SWD #1, formerly known as "Big Eddy Unit #36", into a Devonian Salt Water Disposal well. This well was D/A by Perry R Bass in 1973 through the Morrow formation and TD'd at 12,756'.

Judah has applied for and received an approved Administration Order SWD-1533, dated March 4, 2015, by the New Mexico Oil Conservation Division ("NMOCD") and federal approval which was granted on February 2, 2017. Due to the delay in Federal approval, Judah has requested a 12 month extension from the NMOCD (request attached).

Bass Oil Producing Co. has worked very closely with Judah in the proposed re-entry of this well. There are many benefit for both companies in lowering the completion and producing cost of any newly completed wells that would be in close proximity of the proposed water disposal well.
