The combined gas spacing units for these wells include N/2 of Section 27, E/2 of Section 28, entire Section 33, and W/2 of Section 34, Township 23 South, Range 34 East, and N/2 of Section 4, Township 24 South, Range 34 East, NMPM, Lea County, New Mexico.

Commingled oil and gas production from the wells shall be measured and sold at the Antelope Ridge Unit Facility Tank Battery (CTB), located in Unit L of Section 34, Township 24 South, Range 34 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from the Antelope Ridge Unit Well No. 9, Antelope Ridge Unit Well No. 11, and Antelope Ridge Unit Well No. 12 are metered at their respective well pads prior to commingling. The Antelope Ridge Unit Well No. 7 and Antelope Ridge Unit Well No. 8 shall be metered separately at the CTB before commingling with the other wells. The Antelope Ridge Unit Well No. 2 and Antelope Ridge Unit Well No. 3 shall be measured with a combination of metering and well testing at the CTB.

The allocation meters shall be calibrated quarterly in accordance with Division Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations.

This approval is subject to like approval from Bureau of Land Management before commencing commingling operations.

The Operator shall notify the transporter of this commingling authority and the Hobbs District Office prior to implementation of commingling operations.

For future additions of wells and leases to this commingling operation, notice shall only be given to those interest owners in the wells and leases to be added, in accordance with Division Rule 19.15.12.10 C (4) (g) NMAC.
